Instructions

Each applicant will submit a declaration (maximum two pages) containing:

- 1. Its motivation to join the applicant consortium and competences it brings to it (and later the KIC, if the proposal is successful, incl. the start-up phase);
- 2. Its commitment towards the KIC (including financial and non-financial commitment);

The minimum font size allowed is 11 points, Calibri or Calibri Light. All margins (top, bottom, left and right) should be at least 15 mm (not including any footers or headers).

This document must be signed by the authorised legal representative of the applicant's organisation.

The coordinator will be responsible for merging all applicant's documents in one PDF ("portable document format", compatible with Adobe version 5 or higher, with embedded fonts). Other file formats will not be accepted by the system. There is an overall limit of 10 Mbyte to the size of the file.
