Prof. Dr. Ir. Koenraad Debackere has been with K.U. Leuven since 1995. In 1993, 1995, 1997 & 2008 he won Best Research Paper Awards from the American Academy of Management and the Decision Sciences Institute in the area of technology and innovation management. In 2006, he won the 3-yearly VBO-prize for scientific excellence. In 2007, he was appointed Honorary Professor at the Science Policy Research Unit, U. Sussex. In 2009, he obtained the 5-yearly Research Publication Award from the International Association for Management of Technology. Since 1999, he is actively engaged in technology transfer activities as managing director of K.U. Leuven Research & Development and Chairman of the Gemma Frisius Fonds (the venture fund) of the K.U.Leuven.

He is co-founder and chairman of Leuven.Inc, the innovation network of Leuven high-tech entrepreneurs. He is a board member of IWT-Vlaanderen, the Flemish government agency that supports innovation in Flemish industry. Since 2005, he is the general manager of K.U.Leuven.
